Notice is hereby given that the Monterey County Office of Education, under its County Superintendent of Schools, hereinafter referred to as MCOE, will receive up to, but no later than 1:30 p.m. EDT, Monday, October 9, 2017, sealed bids for the award of contracts for use by MCOE, other education and public agencies throughout California, and other eligible jurisdictions. Awards shall be made for an initial one-year term and extensions as allowed by law.

MCOE is cooperating as a Member Agency with the Association of Educational Purchasing Agencies (AEPA) and the CalSave cooperative purchasing programs. MCOE intends that applicable purchases under this bid be piggybackable by other agencies as allowed by law and that, where eligible, items under contract be part of a Standard School Supply and Equipment List.
